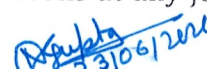

1. Bid price

5. Bid Validity

Bid shall remain valid for a period of not less than 120 days after the deadline date specified for submission. The bidder shall not be entitled to modify, vary, revoke or cancel his bid during the said period.

6. Evaluation of Bids

The purchaser shall evaluate and compare the bids determined to be substantially responsive i.e. which
a. are properly signed; and

- b. conform to the terms and conditions and specifications.
- c. submitted the sample free of cost for quality assurance to BSACS.

The quotations would be evaluated separately for each item/s.

7. Shelf Life:-

The supplied Drugs must have 02 years (24 months) of shelf life at the time of supply.

8. Testing

The suppliers have to submit testing report from any consortium lab along with the bill for payment.

9. Award of Contract

- a. The purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive.
- b. Notwithstanding the above, the purchaser reserves the right to accept or reject any bids and to cancel the whole bidding process and reject all bids at any time prior to the award of the contract.
- c. The bidder whose bid is accepted will be notified of the award of the contract by the Purchaser prior to the expiration of the quotation validity period. **The terms and conditions of the accepted offer shall be incorporated in the purchase order.**
- d. The purchaser reserves the right at the time of award of contract to increase or decrease the quantities of items indicated by 20% without any change in the unit price or any other terms and conditions.
- e. If L1 tenderer's work is not satisfactory then BSACS can allow L2 tenderer to provide above mentioned drugs at L1 rates
- f. If the price quoted by any bidder is below the market prices which may affect the quality of the product then BSACS can use the discretion to reject the tenderer's bid.

10. Delivery Period & Place:

Within 20 days from the date of award of contract.

11. Penalty

- a. **For delayed in supply** – 2 % of the value of the contract per week or part thereof after expiry of the delivery period subject to a maximum 30%.
- b. **Failure of the delivery** – If the supplier fails to deliver any or all of the above mentioned drugs, the purchaser may initiate to blacklist the supplier and the required drug/(s) will be procured from market.
- c. The supplier shall immediately replace defective drug/(s) if any supplied items are found to be of sub Standard quality.

12. Payment:

- a. No advance payment will be made. Payment will be made on receipt of POD (duly signed and stamped)/bills/ invoices (as prescribed under GST Act 2017).
- b. Payment will be made after submission of the invoices (as prescribed under GST Act 2017) along with proof of goods acceptance certificate duly signed and stamped, after statutory deduction (like TDS, penalty etc).
- c. The payments will be made only through Public Financial Management System (PFMS) to agency.

14. Submission of Bid:

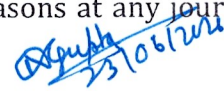

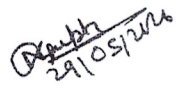
बैठक की कार्यवाही

दिनांक 08.04.2026 को प्रकाशित "Annual rate Contract (ARC) of Different types of Drugs for BSACS" से संबंधित निविदा सूचना प्रकाशित करायी गयी थी। नियत तिथि (21.04.2026) तथा समयानुसार समिति को एक भी निविदा प्राप्त नहीं होने के कारण पुनः उक्त निविदा का अवधि विस्तार देते हुए एक सूचना समाचार पत्रों पर प्रकाशित करायी गयी थी। परन्तु नियत तिथि (29.05.2026) तथा समयानुसार केवल एक निविदा प्राप्त हुए। जबकि कम से कम तीन निविदाएँ प्राप्त होना वांछित है।
