

1. Bid price

Last three financial years Audit Report from duly qualified Chartered Accountant Report showing details (balance sheet and profit & loss) of their annual turnover should be submitted. Auditor/only C.A. Certificate of turnover will not be accepted.

5. Performance guarantee-

The successful bidder will submit the performance security for 10% of the total contract value in the form of Demand Draft/ Bank guarantee issued by a local nationalized bank in favor of Project Director, Bihar State AIDS Control Society, Patna payable at Patna within 07 (seven) days after awarding the work valid up to ninety (90) days after the date of completion of 03 years of warranty or all contractual obligations by the contractor.

6. Warranty

6.1 The supplier warrants comprehensively that the goods supplied under the contract is new, unused and incorporate all recent improvements in design and materials unless prescribed otherwise by the purchaser in the contract. The supplier further warrants that the goods supplied under the contract shall have no defect arising from design, materials and specification or workmanship.

6.2 The warranty period must be at least 3 (three) years from the date of installation, commissioning & acceptance of the above mentioned items by the purchaser.

6.3 Under the warranty period the supplier or their authorized agent must repair or replace the defective part/ (s) without any charge within 24 hours after receiving the complaint from designate Officer.

7. Delivery, Installation & Commissioning of Scanner & Printers

Within 45 days from the date of awarding the work order by Bihar State AIDS Control Society, Sheikhpura, Patna-14. The selected agency must-

- a. Complete Delivery, Installation, testing & commissioning of Barcode Scanners & Printers as per technical specifications (Annexure II).
- b. All engineering, equipment, labour, if required for satisfactorily completion of work as per Specification.
- c. Any other ancillary work, related to but not mentioned above, required for satisfactory completion of the job.

8. Validity of Bids

Bids shall remain valid for a period of not less than 120 days after the deadline date specified for submission. The bidder shall not be entitled to modify, vary, revoke or cancel his bid during the said period.

9. Evaluation of Bids

The purchaser shall evaluate and compare the bids determined to be technically responsive i.e. these

- a. are properly signed; and
- b. conform to the terms and conditions and specifications.

10. Award of Contract

- a) The purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.
- b) The purchaser reserves the right at the time of award of contract to increase or decrease the quantities of items indicated by 15% without any change in the unit price or any other terms and conditions.
- c) Notwithstanding the above, the purchaser reserves the rights to accept or reject any bid or all bids at any time prior to the award of contract.
- d) The bidder whose bid is accepted will be notified of the award of the contract by the purchaser prior to the expiration of the bids validity period. The terms of the accepted offer shall be incorporated in the purchase order.
- e) If L1 tenderer's work is not satisfactory then BSACS can allow L2 tenderer to provide above mentioned items at L1 rates
- f) If the price quoted by any bidder is below the market prices which may affect the quality of the product then BSACS can use the discretion to reject the tenderer's bid.

11. Penalty

- a. **For delayed in supply** - 2 % of the value of the contract per week or part thereof after expiry of the delivery period subject to a maximum 30%.
- b. **Failure of the delivery** - If the supplier fails to deliver any or all of the above mentioned items, the purchaser may initiate to blacklist the supplier and the required item/(s) will be procured from market.
- c. The supplier shall immediately replace defective item/(s) if any supplied items are found to be of sub Standard quality.

12. Payment

- a. No advance payment will be made. Payment will be made on receipt of POD (duly signed and stamped)/bills/ invoices (as prescribed under GST Act 2017).
- b. Payment will be made after submission of the invoices (as prescribed under GST Act 2017) along with the proof of goods acceptance certificate duly signed and stamped, after statutory deduction (like TDS, penalty etc).
- c. The payments will be made only through Public Financial Management System (PFMS) to agency.


